Management's Responsibility



Scrutinizer's Responsibility



Our responsibility as a Scrutinizer was to ensure that the e-voting process both through E-voting and postal ballot is conducted in a fair and transparent manner and to render you a Consolidated Scrutinizer's Report of the total votes cast "in favor" or "against" on the resolutions, based on the reports generated through Scrutinizer's secured link as provided by NSDL.

We submit our report as under:-

1. The e-voting period remained open from December 24th, 2023, 09:00 A.M. to December 26th, 2023, 05: 00 P.M.



2. A person whose name was recorded in the register of members maintained by the Club as on the cut off date i.e November 24th, 2023 was entitled to vote on the proposed resolutions as set out in the Notice.
3. The votes were unblocked on December 27th 2023 at 04.35 PM in the presence of two witnesses Mr. Sunil Sareen, Member of the Club and Mr. Sushil Kumar Dwivedi, Member of the Club, who are not in the employment of the Club. They have signed below in confirmation of the votes being unblocked in their presence.


4. Physical Ballots were received upto 11:30 A.M. on December 26th, 2023 through self-addressed business reply envelopes.
5. Physical Ballots were also received from members present at the AGM venue, between 11:30 A.M. upto 1 :30 P.M. on December 27th, 2023.
6. Thereafter, the details containing, inter alia list of members, who voted "For" and "Against" were downloaded from e voting website of NSDL i.e. <https://www.evoting.nsdl.com/>
7. Total votes cast were 868 (128 by E -voting and 740 by physical Ballots) and no Ballot papers were received late after the closure of ballot period. Total number of invalid ballots for Resolution No. 1 are 29, Resolution No. 2 are 25 & Resolution No. 3 are 28 due to being blank or duplicate or defective and hence, were invalidated.

9. Total Votes cast as follows:-

652 for Resolution No. 1, 670 for Resolution No. 2 & 719 for Resolution No. 3 were valid physical ballots and were recorded. 119 for Resolution No. 1, 119 for resolution No. 2 and 126 for resolution No. 3 were valid E votes. Total number of invalid ballots for Resolution No. 1 are 29, Resolution No. 2 are 25 & Resolution No. 3 are 28 due to being blank or duplicate or defective and no physical ballot papers were received late after the closing of ballot box on 27th December, 2023 at 11 :30 a.m.

Based on the foregoing, resolution no. 1 and 2 have been passed by requisite majority.

Further, for resolution no. 3, the candidates who have obtained highest votes have secured positions, as 25 members of Management Committee.
